On behalf of the Trust, I would like to thank Karen for broadening the range of activities and services within the Cheviot Centre and the Glendale area, all helping to benefit the Glendale Community. In particular, the Trust thanks Karen for her role in being one of the main exponents of the Rural Advocacy programme. We wish Karen well in her future endeavours.

Announcement of the appointment of the new Operations Manager: Lesley Robson

The Trust has appointed Lesley Robson to the new position of Operations Manager.

Lesley comes to the Trust with a wealth of experience in community development, high level relationship building and strategic operational management.

She spent close to two decades working in foreign policy in post-war Iraq at a senior government level, supporting Iraq's efforts to rejoin the international community and rebuild diplomatic relations.

She returned home to Northumberland in 2016, then spent 8 years as Community Manager for the RNLI in Northumberland & the North East - managing over 750 volunteers, a complex buildings portfolio of over 40 lifeboat stations and shops and drove fundraising campaigns in collaboration with local communities and external stakeholders.

Working with our partners at NCC, we disburse the log bank and the food bank to support people most in need throughout Glendale.

c. Post Office

Saving the Wooler Post Office from closure was the highlight of last year and is an achievement for which the Trust is immensely proud. It has meant that an active business and social hub in the community continues and more social housing is available as the postmaster's dwelling is converted into a family home.

Karen, working closely with the Cllr Mark Mather, and the with the help of local partners & funders, including WPC, Barmoor, and various members of the community, all managed to save the Post Office from closure.

a. **Bob Burston**

Mr Bob Burtson – ex Trustee and friend of GGT/ex St. Mary's Church.Vicar & ex Wooler resident for many years.

Mr Burston wanted to pay tribute and give recognition to Duncan Davidson, who sadly passed away recently. Mr Davidson generously aided the biggest investment in the Trust's history which went towards financing the purchase of the land that is now Butler Court, which was then sold to Home Housing. GGT kept the High Street shop frontage for conversion to shops and flats. Mr Davidson's kind loan was interest free. For this, the Wooler community is eternally grateful to Mr Davidson and it forms part of his legacy in the area. Everyone applauded this recognition and the Trust appreciated Mr Burston's kind words and desire to have this noted.

Mr Burston recommends that The Trust should send a letter to the family of the late Duncan Davidson, thanking him for his generous financial support when the GGT was first starting out.

- b. **Bob Burston** reminded everyone of the GGT's approaching 30th anniversary in 2026 – cause for celebration.
- c. **Jenny Pollock** Why has the role of CEO been replaced with Operations Manager. RL stated the latter better reflected the role which largely involves management. High-level strategies have in the past and will continue in the future, to happen with the staff and trustees coming together to discuss new directions, focus and strategies.
- d. **Jenny Pollock** asked how many of the trustees were appointed or elected; RL stated they were all elected.
